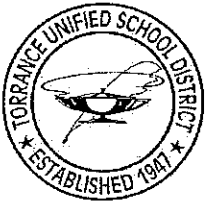

AUTHORIZATION TO PARTICIPATE AND RELEASE OF LIABILITY FORM

1. I certify that information given on this application is accurate. I have read and agree to abide by the California Interscholastic Federation (CIF) Student Athlete's Code of Ethics as well as the policies and procedures established by the Torrance Unified School District.
2. I understand that sports and athletics entail unknown and unanticipated risks, which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I acknowledge that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. As a participant to this summer program I acknowledge that the risks may involve but are not limited to: being struck by another participant or ball, or all that may result in contusions, sprains, fractures, broken bones or concussions.
3. I agree to provide proof of medical insurance with this authorization form. I agree and fully understand that Torrance Unified School District will provide liability only for any negligence on its part which occurs during authorized practice sessions, i.e., when an authorized athletics coach is present and supervising the athletic event/activity.
4. I hereby give my consent to my daughter/son to attend the Torrance Unified School District Summer Athletic Program and enroll in the program(s) for which a selection has been made. I agree to ensure that my son/daughter has access to a parent (i.e. home, work or cell phone) in case of emergency, class cancellation, campus evacuation, or any other non-planned event.
5. I understand and accept full academic and financial responsibility for selection(s) made on this application. The practice session(s) are not a prerequisite for my son/daughter participating in athletics during the regular school year. There will be no grades or credit issued for the sessions.

I, the undersigned, hereby release and discharge the Torrance Unified School District, including its officers, employees, agents, servants and volunteers (herein collectively referred to as the "District"), from all liability arising out of or in connection with the above-described practice sessions that may be filed on behalf of or for the above-named minor. For the purposes of this agreement, "liability" means all claims, demands, losses, causes of action, suits or judgments of any and every kind on account of any injury to the person or property of the above-named minor that occurs during the above-described practice sessions and that results from any cause other than the negligence of the District.
