TRANSPORTATION FOR SCHOOL-RELATED TRIPS

All schools in the Torrance Unified School District require the completion of permission forms which indicate that parents have given permission for their students to participate in voluntary events away from school premises with transportation provided by individuals including coaches, parents, sponsors, or other adults at least 21 years of age.

The Torrance Unified School District does not provide transportation to certain voluntary events. It is solely the parent's responsibility to arrange for transportation for his/her student if the parent wishes his/her student to attend and participate in the event(s).

If, as a parent or guardian, you would like to volunteer to drive students, or wish to grant permission for your student to drive him/herself to and from the event, the attached form must be completed, signed and returned to the school prior to the event.

TRANSPORTATION FOR SCHOOL-RELATED TRIPS

DRIVER INSTRUCTIONS

When using your vehicle to drive to a school-related sports event:

1. Prior to using a student's personal vehicle to drive to a school-related event: Provide school with a copy of student's driver's license and proof of current insurance.
2. Students must have in their possession proof of current insurance and a valid driver's license.
3. Check the safety of your vehicle: tires, brakes, lights, horn, suspension, etc.
4. Carry only yourself and/or siblings. No student driver can transport any other student aside from his/her siblings.
5. Require each passenger to use appropriate passenger restraint systems or safety belts in accordance with the law.
6. Obey all traffic laws.
7. Take the most direct route to the destination or event without unnecessary stops.
